

# Code of Conduct in Response to Covid-19

## Arrival at School

I the STUDENT agree that:

- On my journey to school, I will adhere to social distancing where possible and minimize the touching of surfaces on public transport etc.
- To only share a car with members of my household as government guidance states.
- To follow the latest government advice on wearing face masks on public transport.
- To arrive on the school patio in time for my designated "bubble" to begin their school day.
- To socially distance on the patio at least 2 metres apart.
- Where possible, provide my own sanitizer for my own use (between classes and eating, students will have access to soap and hot water).
- When on the school site, I will adhere to social distancing at all times in the school building and out of the school building.

## Health Screening and Early Collection including Consequence of Breaking this Code

I the PARENT/ CARER agree:

- To the school carrying out health screening as required.
- To be reachable via phone (throughout the school day) so that I can be informed of my child being sent home if they are ill or have breached this code of conduct.
- To keep my child at home should they display even the mildest symptoms of any illness.
- To notify the school of any Covid-19 related health issues at home and the results if a negative or positive Covid-19.
- That if I wish to collect my child instead of allowing them to go home by themselves, I must collect them within 40 minutes.

I the STUDENT agree:

- To inform a member of staff immediately if I start to feel unwell or exhibit any symptoms.
- To follow all instructions given by staff including first aid instructions.
- To leave the school site and go home if instructed by staff and only after my parent/ carer has been spoken to by the school and informed of this.

## Movement to Lessons

I the STUDENT agree to abide by the new arrangements, which are:

- Following the one-way system in the school.
- Not running around inside the school building or outside the building including the field and patio.
- Moving in single file with social distancing and not speaking or eating to reduce the risk of airborne transmission of Covid-19.
- Only eating in the designated eating times and eating places.
- Ensuring I maintain at least 2m distance between myself and any other person.
- Avoiding touching my face.
- Behaving safely and not deliberately coughing, spitting or sneezing.
- In emergencies, by using my elbow to cough or sneeze in to.
- Following instructions at all times.

## During Lessons

I the STUDENT agree in my lessons, that I will:

- Maintain a safe distance of at least 2m from any other person in the room.
- Sit in my designated seat (the teacher will instruct), and not to change seats.
- Avoid touching unnecessary surfaces e.g. on my way to my desk, I will not touch other desks en route.
- Not share any equipment with another student.
- Only go to the toilet at the designated time for my class, or in emergencies, wait to be escorted.
- Not joke about the current Covid-19 situation.
- Avoid touching my face.

- Not cough or sneeze, near, or on, another student or member of staff.
- Use a tissue, if I accidentally cough or sneeze and dispose of this as directed by the class teacher, which if safely for social distancing, could be placing into the designated bin or put into my bag and dispose when I return home – the teacher will direct.
- Stay focused on my learning throughout the whole lesson.
- Bring my own equipment to school and not share this with anyone else.
- Take home my exercise book and bring it in for the next time and not leave anything in school.
- Use a tissue, if I accidentally cough or sneeze and dispose of this as directed by the class teacher, which if safely for social distancing, could be placing into the designated bin or put into my bag and dispose when I return home – the teacher will direct.

### Break Time

I agree to abide by the new arrangements for break time by:

- Staying in my classroom until instructed to leave.
- Following my 'bubble' and the member of staff who is leading using social distancing.
- Bringing my own food and non-fizzy, non-caffeinated drink for break and/ or lunch.
- Remaining at least a social distance from any other person when outside the classroom having my break or lunch.

### Toilets

I agree to observe the rules and regulations as directed below:

- To use the toilet before I come to school as directed by staff.
- To only use the toilets designated for my "bubble".
- To only use the toilet at the designated time for my group.
- To observe the social distancing rules in the toilet areas by staying at least 2m from the nearest person.
- To wash my hands with soap and warm water for at least 20 seconds.
- To not congregate in the toilet area, only enter and leave the area when this complies with the social distancing rules (a queuing system will be in place).

### Visitors to School

I agree to support the following:

- There will be no visitors permitted on the school site so I will not come onto the school site, instead if I wish to communicate with the school, I will do this by email or by telephone.

### Fire Evacuation

I the STUDENT agree to:

- Maintaining at least a 2m distance from any other person where possible.
- Following the teacher's instructions including filing out and going to the designated fire exit as directed by the member of staff.

### Leaving School

I agree to abide by the new arrangements:

- By leaving the school site immediately, ensuring that I maintain at least 2m distance between myself and any other person.
- By leaving at the designated time and not waiting for friends, however, I can wait for members of my household (e.g. sister or brother) as long as this is socially distanced from any other waiting household and is outside the school building.
